**Stanley Kriegsman, President Emeritus**

**Good afternoon Brother and Sister FOP Members And Guests,**

**I retired from NYPD after serving the citizens of NY for 23 years. This past September I am proud to say that I'm retired from the NYPD for 28 years. My outlook on this is that for the past 28 years the City of NY has been paying me not to work for them. What a wonderful country we live in.**

**In 2004, I decided to relocate from the Empire State to the Sunshine a State and I've never looked back. living in an over 55 community is like senior camp.**

**Well, one beautiful, bright, sunny, Florida day I was sitting on my patio surfing my laptop. I opened a page where FOP merchandise was being sold. Well, being a card carrying member of a New York Lodge for about 20 years, I thought to myself, why not transfer my membership to my new home State of Florida. I was able to contact a President of an FOP Lodge in palm Beach County and asked if I could transfer my membership to their Lodge. His reply was, "we don't take outsiders." He then referred me to another Lodge and I received the same answer, "we don't take outsiders." I then was given the phone number of the FL Associates Lodge. I believe I spoke to Chuck Stoddard who advised me that since I was a retired officer I did not belong in the Associates Lodge. With all of this rigmarole going on, I just dropped the idea of transferring my FOP membership.**

**Then came another fine Florida day In October 2007. Arnie Dansky, Norm Rapport and myself were sitting on the deck of our communities' pool, with our feet dangling in the water. After all, the three of us came from New York and we were joined as brothers through our law enforcement backgrounds. Arnie retired as DI from the NYPD, Norm retired as a Lt from the NYC Transit a Police and I as a Sergeant from NYPD. I discussed the run-around that I had received and the three of us decided to try and start our own FOP Lodge just for us New Yorkers.**

**I went home and composed 2 emails regarding our intention, one to Chuck Canterbury, and one to Jim Preston. I left my home to play a round of golf, Well, by the time I returned home I had a message from Edgar Boroughs, at that time he was the a District 4 Director. I had set up a meeting with Edgar to discuss our forming a Lodge that would only accept as its members retired law enforcement officers from NY who have relocated to the Sunshine a State,**

**On November 7, 2007, ten members attended our swearing in ceremony, with Edgar leading us in the FOP oath, thus Lodge NY 3100 was formed. And, that's when we discovered that there are two types of FOP Lodges, one which does not take outsiders because they are labor lodges and they do not want outsiders to know their union business. then there are the fraternal lodges, which we became.**

**BTW, the 3100 in our name represents the old phone number of the NYPD's headquarters. Spring 7, 3100. It is also the name of the NYPD's magazine, Spring 3100, and our Police Officer shield, which is on the back cover of this publication depicts the shield number 3100.**

**Over the past 8 years There were quite a few hurdles that we had to jump over and we succeeded with the assistance and support of the vast majority of our Florida FOP Brothers and Sisters.**

**Eight years later, our 550 members represent 34 law enforcement agencies in the State of NY and 26 of our members, who are retired officers from NY are presently working for Florida Law Enforcement Agencies.**

**We decided that our main charity is going to be us. By us I mean fellow law enforcement officers throughout the country. After hurricane Sandy struck NY we sent the NY FOP a check for \$2600 to assist our brothers and sisters who were negatively effected by that devastating storm. We sent money to the officers whose homes**

**In our 8 years we have been called upon by some PDs to assist in picketing for their contractual needs. We looked at it this way, we can't get fired by the Mayor or their staff, because we don't work for them.**

**We have gone out and held election placards in different locations for candidates that support our police. We have members volunteering a various police agencies assisting the active detectives in trying to close their cases.**

**My board of officers, my members and myself have made our Lodge a viable entity in the FOP, in that we have brought to the forefront the meaning of FRATERNAL.**

**I have been at the helm of our ship for 8 years, and now it is time to let someone else take the reigns of the most Unique Lodge in the Nation.**

**I sincerely thank all of our Florida brethren for their assistance in getting us off the ground and putting us on the map.**



# Crime Statistics



The NYPD maintains statistical data which is used as a management tool in reducing crime, improving procedures and training, and providing transparency to the public and government oversight agencies. In 1994, the department implemented CompStat, which through management, statistics, and accountability, successfully drove down crime to record levels not seen since the 1950s.

The department provides up-to-date crime-related statistics in the seven major crime categories on the citywide, borough, and precinct levels, as well as historical crime data. The public can also access this data through the department's **CompStat 2.0** portal.

The weekly CompStat page and CompStat 2.0 were modified to include two sex crime categories. The first is "UCR Rape," which consists of all crimes in the FBI's Uniformed Crime Reporting (UCR) rape definition. The second category is "Other Sex Crimes," which consists of all other crimes of a sexual nature.

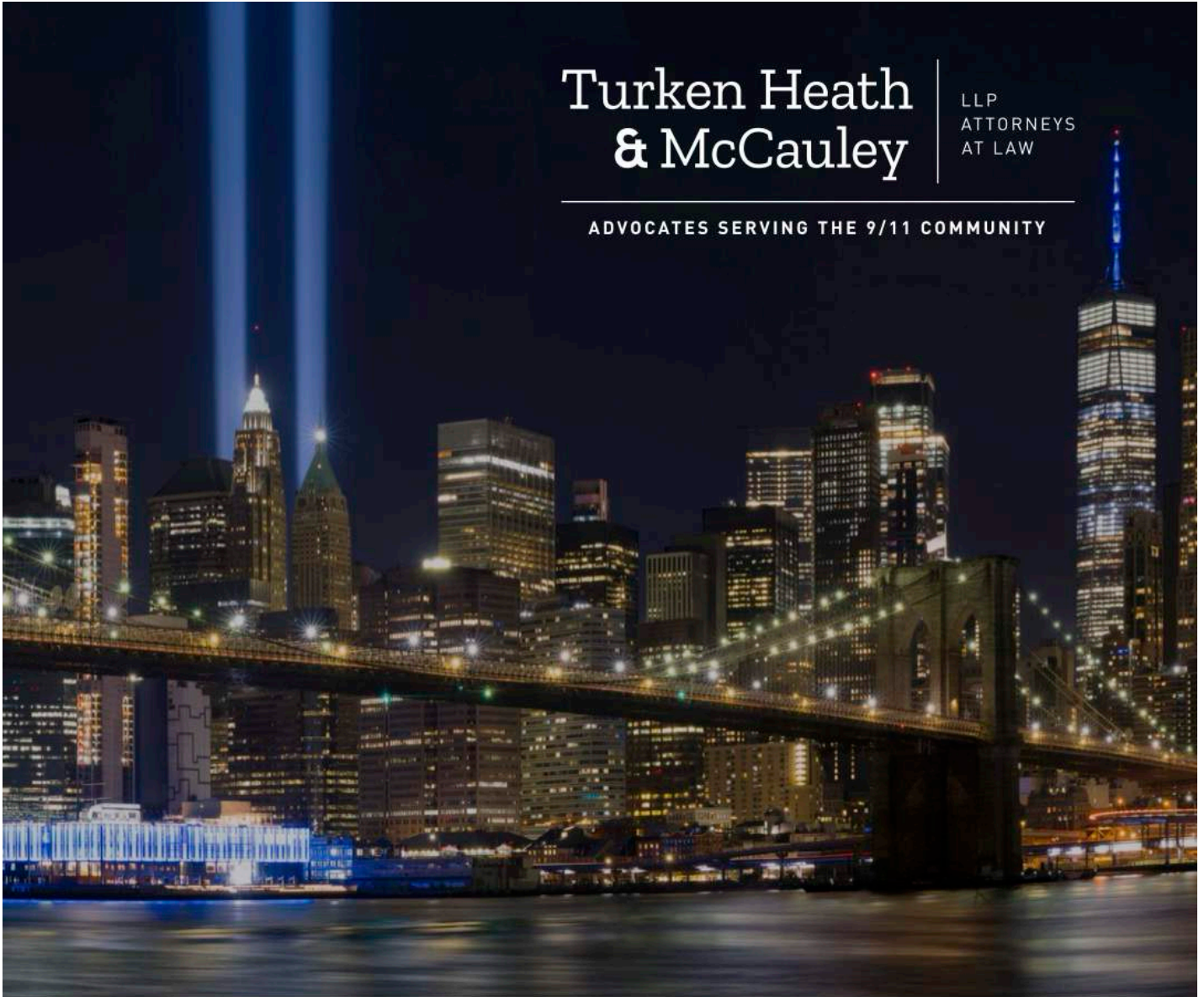

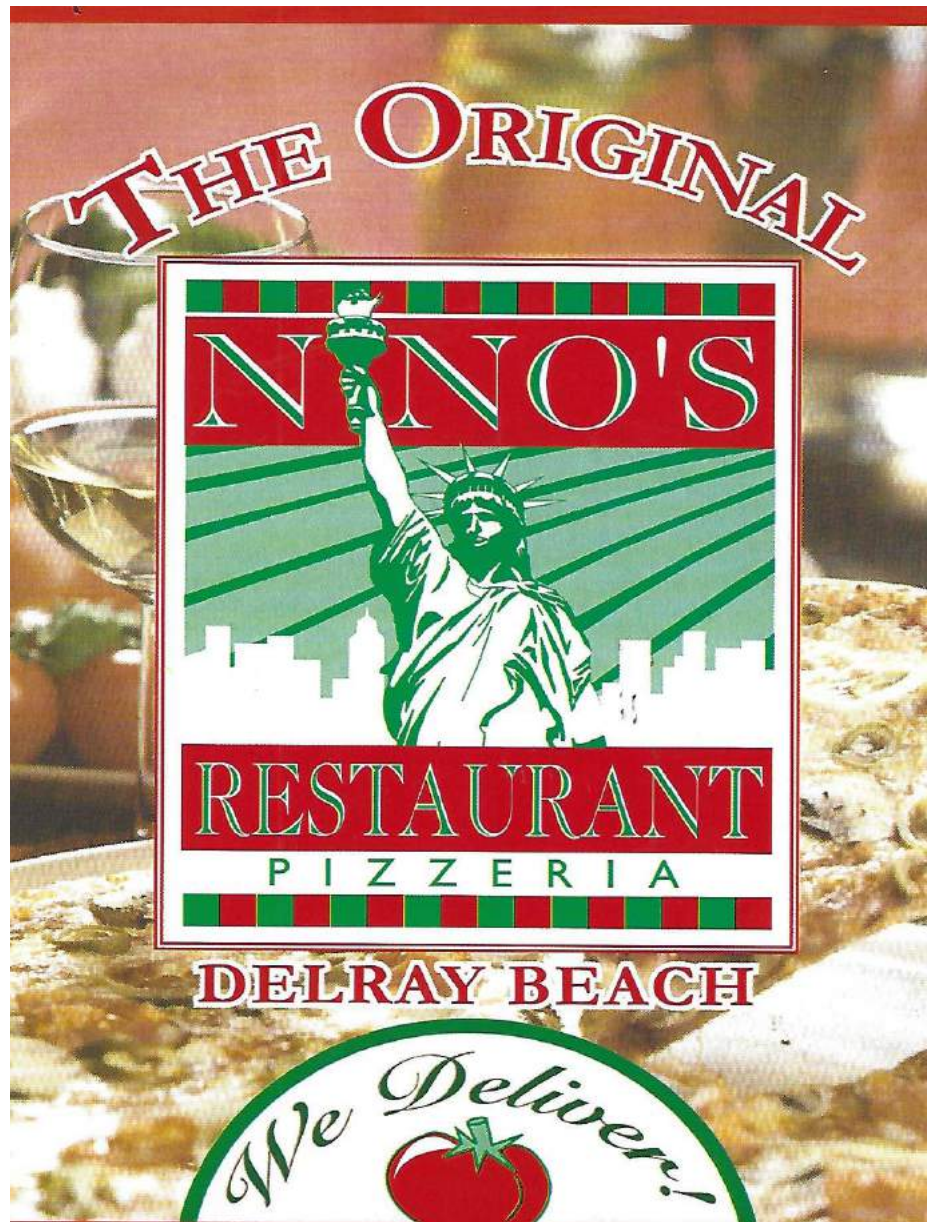
