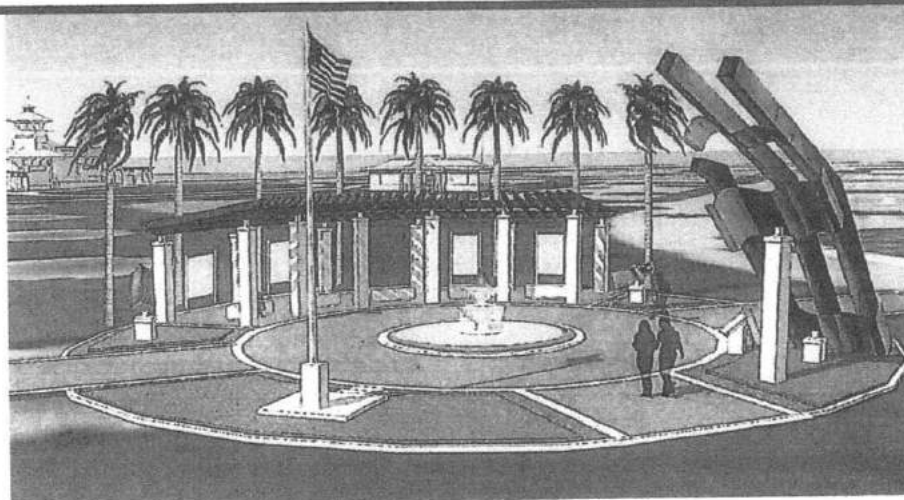

NYS Comptroller Thomas Napoli has announced a Cost-of-Living Adjustment (COLA) of 3% for September 2022 for a maximum annual increase of \$540.00, or \$45.00 per month before taxes.

Eligible retired public employees automatically receive an annual COLA increase each September.

Who is eligible to receive a Cost-of-Living Adjustment?

- Disability retirees, regardless of age, who have been retired for at least years
- Service retirees who are at least age 62 AND who have been retired for at least years
- Service retirees who are at least age 55 AND who have been retired for at least 10 years years
- Spouses receiving a Joint-and- are eligible to receive 50% of the monthly COLA for which the retiree would have been eligible

How COLA is Determined?

COLA payments be calculated based on 50 percent of the annual rate of inflation, measured at the end of the State fiscal year (March 31). The annual COLA will be at least 1 percent, but no more than 3 percent, of your benefit. This percentage is then applied up to the first \$18,000 of your pension as if you had chosen the Single Life Allowance pension payment option, even if you selected a different option at retirement. Using the Single Life Allowance provides you the highest COLA amount possible, since this option offers the highest benefit. If your Single Life Allowance is less than \$18,000, the COLA calculation is based on your actual retirement benefit.

The annual NYCERS COLA letter was mailed on September 20, 2021.

Off-duty NYPD cop critically injured in Bronx mugging

An off-duty veteran NYPD cop was knocked out and critically injured after he was viciously mugged while jogging in the Bronx on Tuesday morning, police and sources said.

The 48-year-old officer was running near 823 Olmstead Avenue when he was jumped by three men at about 10:30 a.m. in a horrific crime that appears to be part of a recent citywide pattern of robberies, according to cops and sources.

One of the suspects punched the cop in the head, knocking him unconscious, sources said.

The cop, an 18-year veteran assigned to the Central Park precinct, was found lying on the sidewalk bleeding from his left ear and unable to stand or speak, sources said.

He had no form of identification on him at the time and was taken to Jacobi Medical Center as a John Doe with a fractured skull and bleeding to his brain, sources said.

The NYPD learned later Tuesday night that he was one of New York's finest. He was listed in critical but stable condition, the sources added.

The perpetrators fled in a black Honda sedan and no arrests were reported, police and sources said.

Police said the suspects made off with the officer's cell phone, keys and wallet, which contained several forms of identification as well as his debit and credit cards.

A witness to the mugging was uncooperative with investigators, sources said.

Mayor Eric Adams visited the injured cop at the hospital on Tuesday night, sources said.

Police Benevolent Association President Patrick Lynch vowed that the department will bring the "cowards" who attacked the cop to justice.

"Make no mistake: we will find them. But we will need the rest of the justice system to step up and do its job, too," said Lynch.

Police said the cop's mugging matched a pattern of 19 robberies in the city since Aug. 1. The first two occurred in Queens, while all others happened in the Bronx, including six just on Monday.

In the last two robberies before Tuesday's mugging, a 36-year-old man was approached by a group of three young males in front of 2353 Quimby Avenue Monday morning.

One of the robbers flashed a knife while the others snatched the victim's cell phone and wallet, which contained ID documents and about \$40 in cash, according to police.

The victim was slashed as he tried to flee. He was treated by EMS at the scene. Surveillance video released by the NYPD captures part of the attack against the 36-year-old, showing three males exit a black Honda double parked in a street and walk towards the victim.

The video then cuts to the suspects chasing the victim man, two of them suddenly turn around and confront a 32-year-old woman and a 48-year-old man who happened to be walking by the black Honda, video shows.

Just as in the previous incident, one of the suspects displayed a knife while the others removed the female's purse, video shows. The purse contained roughly \$1,000 in cash, multiple debit cards and ID documents, cops said.

The suspects jumped into their Honda and drove off. No one was injured in the second incident, police said.

The 43rd precinct, where Tuesday's attack took place, has seen a surge in robberies this year, according to police stats.

As of Sunday, the precinct recorded 461 robberies, compared to the 271 in the same period last year — an increase of 70%, the stats show

New York State Restrictions on Carrying Concealed Firearms

Overview

- Based on a recent US Supreme Court case, more people will have licenses to carry firearms in NYC.
- New York State passed new laws to restrict where those license holders can bring firearms.
- The new laws do not change the way that street encounters are conducted:
 - Officers may stop an individual when the officer has reasonable suspicion that such individual is carrying a firearm (Level 3) and may frisk that individual since the officer has reasonable suspicion that the individual is armed and dangerous.
 - Anyone carrying a firearm is presumed to be carrying unlawfully until proven otherwise.
- Firearms license holders **must** provide their firearms license to law enforcement upon request.

Sensitive vs. Restricted Locations

- Firearms license holders may *not* bring their firearms to **sensitive** locations.
- Firearms license holders may *not* bring firearms to **restricted** locations *unless* the property owner gives permission.

Sensitive Locations

License holders cannot bring firearms into:

- Courts & government offices
- Medical facilities and hospitals
- Places of worship
- Libraries, parks, and playgrounds
- All educational and childcare facilities and campuses (public or private)
- Shelters
- Mental health, substance abuse and disability service providers
- Adult care homes
- Public transportation (including stations)
- Bars, restaurants and cannabis lounges
- Theaters, stadiums, arenas, racetracks, museums, catering halls, and casinos
- Polling locations
- Events that require permits such as parades and outdoor concerts (must post signs)
- Protests, demonstrations, and marches, or any assembly where individuals are gathered to collectively express their constitutional rights of free speech
- Times Square, as designated by signs

Restricted Locations

License holder must have permission from property owner to bring firearms onto:

- Any residential property
- Any commercial property that is not on the list of sensitive locations

Law Enforcement

- On-duty UMOS are *not* subject to any restrictions at sensitive or restricted locations.
- All UMOS (on-duty, off-duty and retired) may carry firearms at sensitive locations.
- Off-duty UMOS and retired UMOS *may* carry firearms at restricted locations *unless* the owner or lessee expressly prohibits firearms on the property.

Deadline for World Trade Center Notice of Participation

On September 7, 2018, then-New York Governor Andrew Cuomo signed the extender on the deadline for filing the Notice of Participation with the New York Police Pension Fund regarding work during the rescue and recovery from 9/11. The deadline date to file is September 11, 2022.

As you are aware, the Notice of Participation is not an application for disability benefits, but merely preserves the right of the member of the service to file for a WTC disability pension if he or she becomes disabled due to a 9/11-related illness, whether active or retired. Failure to file the NOP may preclude the member from receiving a WTC disability pension or death benefit in the future.

The deadline to file for the Notice of Participation to be eligible for the WTC Disability bill or Death bill has been extended many times since the legislation was originally passed. However, September 11, 2022 will most likely be the final deadline.

The NOP Form can be found on the NYPD Police Pension Fund website. You can connect to the PPF website from the DEA website at www.nycdetectives.org

If you believe you already filed, but are not sure, the PPF has listed all the Tax ID numbers of those whose paperwork they've already received under "WTC Information" on the left side of their home page. First, click on "WTC Information" and check the pdf file to see if your number is listed. If it is, then you do not have to re-file. However, if your number does not appear, you must file the form (even if you currently have no symptoms of illness) by September 11, 2022 to be eligible in the future in case of illness and/or death.

Some of the materials you can use to verify your Notice of Participation work claims include your memo books, DARS (daily activity reports), overtime slips, detail rosters, command log entries (either still at your command or at the borough command), signed and notarized affidavits from colleagues verifying you were at the pile, the Morgue, or Freshkills Landfill, photographs taken at the locations during the rescue and recovery, and/or news articles from the rescue and recovery in which you are mentioned.

Please make sure this very important paperwork has been filed with the Pension Fund, but first check the existing pdf to make sure you have not already done so in the past.

NYC CRIME

Three NYPD cops must pay \$191,000 in excessive force, wrongful arrest verdict

Former NYPD Detective Ylka Morales (Facebook) (Head case)

Kleinfeldt, 31, was arrested by Morales and other officers in an undercover drug sting at an apartment building in Brownsville, Brooklyn, in 2015 and charged with the attempted robbery of an undercover cop.

The charges were dropped when video emerged that contradicted the undercover cop's grand jury testimony.

Kleinfeldt alleged that Morales kicked him twice in the face while he was handcuffed, lying facedown on the ground and Ortega, 46, punched him once in the stomach during the arrest.

His lawyer, Michael Lumer, had hoped to tell the jury about Morales' "fantastical and inconsistent" remarks on Facebook blaming a positive drug test that got her kicked off the force on a rival cop's Santeria spell.

"I was drugged/poisoned and framed by NYPD Narcotics Detective Ali Dee because I ousted her for being corrupt," Morales wrote on June 3, 2019. "Don't think I don't know you've been using Santeria Spells to do bad things to people at work.>

"Not only did you poison me with food, you've been feeding male cops in [Narcotics Bureau Brooklyn North] for the past few years food you bring from home mixed with your pubic hairs and vagina fluids to give yourself power," Morales wrote on the social media site.

Judge Rachel Kovner wouldn't allow the Santeria claims to be used at trial to assail Morales' credibility, but video from the arrest gave Kleinfeldt plenty of material.

The undercover cop, identified at "UC 217, "claimed that he passed money to a woman, then watched as she handed it to Kleinfeldt, as part of a crack cocaine transaction. The video shows no handoff took place, and it contradicted the undercover's claims that Kleinfeldt and several others surrounded and robbed him.

When pressed on the inconsistencies, the cop tried to paint the drug deal as a tense episode, with his memories sharpened by being threatened and robbed.

"When was the last time someone threatened your life to shoot your head off at a crack house in a dark room by yourself? That's what stands out," the cop said to Lumer. "How long did it take you, when somebody put a gun to your head, to remember it?" the officer asked.

The jury hit the undercover cop with the bulk of the damages, \$134,100, while Morales was ordered to pay \$49,100 and Ortega \$7,900.

Kovner will rule on whether the cops are covered by qualified immunity in the coming months.

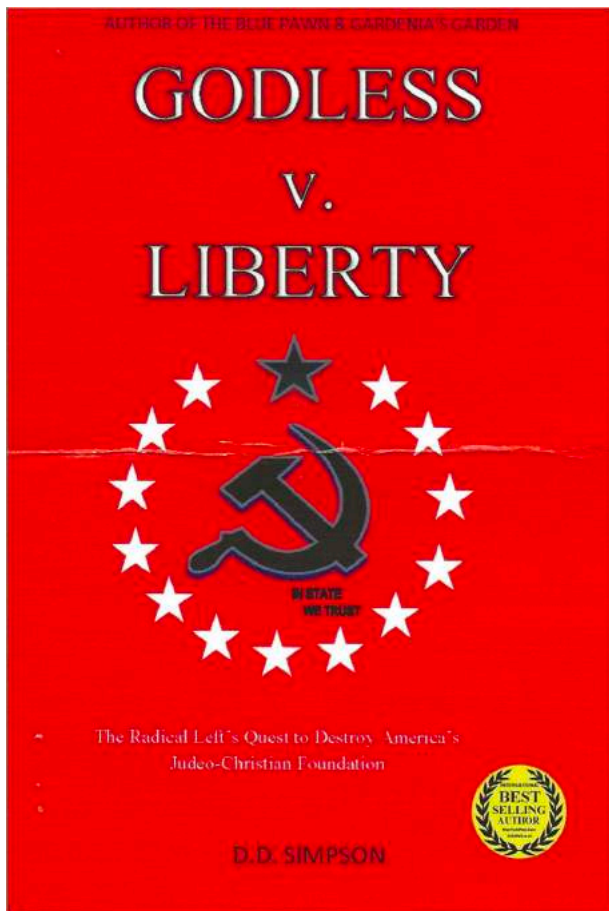

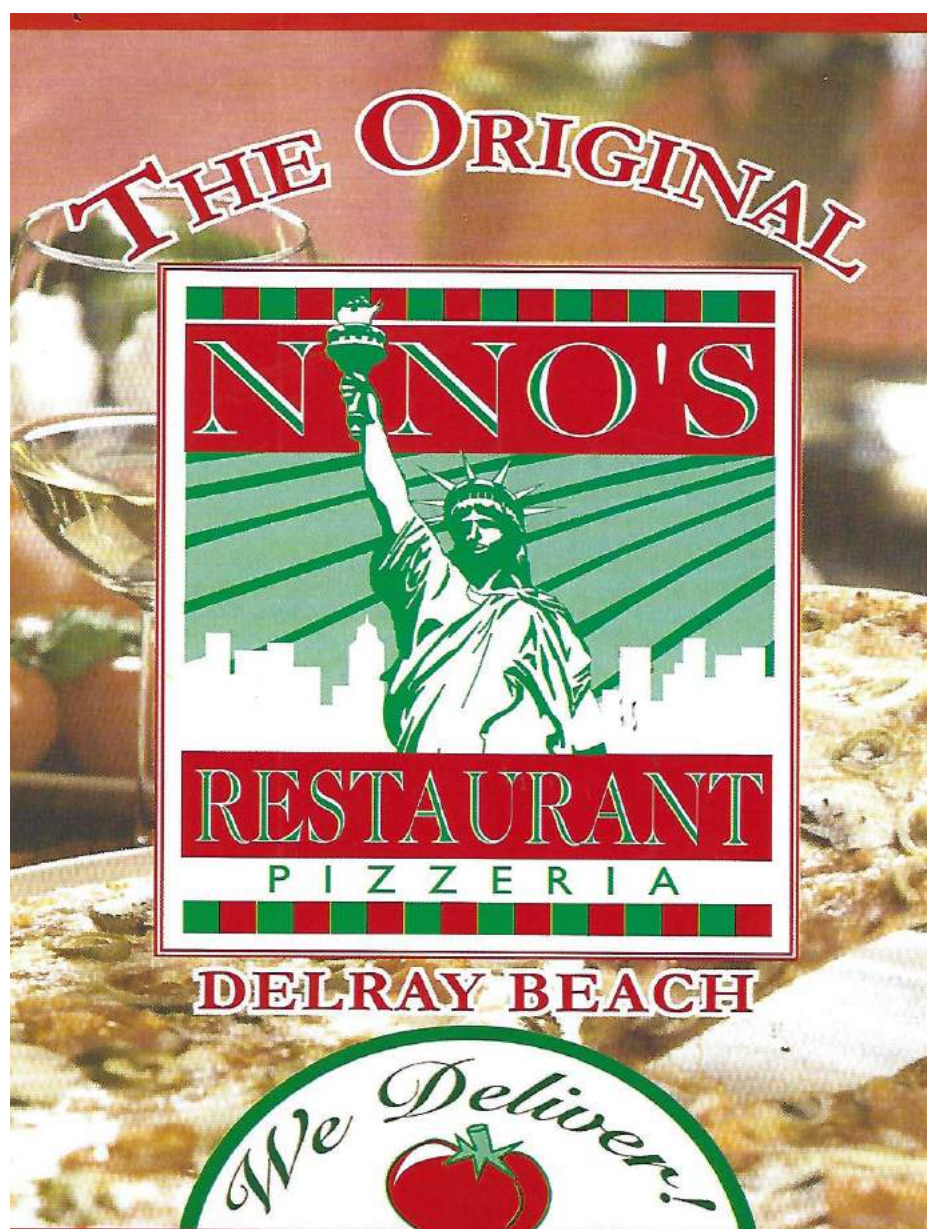
