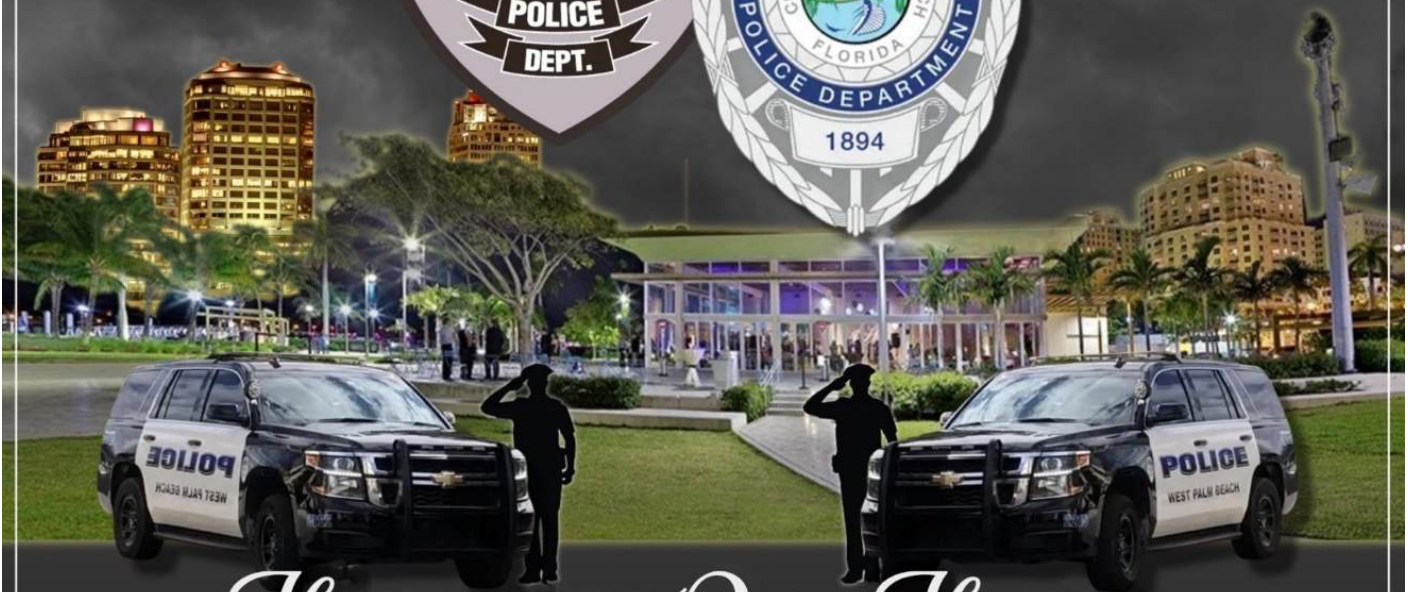

# JUSTICE FOR NYPD SERGEANT ERIK DURAN LEGAL DEFENSE FUND

The National Police Defense Foundation (NPDF), a congressionally recognized and IRS designated non-profit organization, would like to bring to your attention the plight of NYPD Sergeant Erik Duran, who was found guilty of manslaughter in February 2026, in a case where the NPDF feels a miscarriage of Justice occurred.

In August 2023, Sgt. Erik Duran, a highly decorated member of the NYPD, was supervising a “buy and bust” operation in the Bronx. One of the suspects attempted to evade capture by mounting a nearby motorcycle and driving it on the sidewalk, directly at responding officers. Fearing that his officers would be seriously injured or killed by fleeing felon Eric Duprey, Sgt.

Duran grabbed an Igloo cooler and hurled it at Duprey to divert him from crashing into his officers, their prisoner, or bystanders.

Sgt. Duran’s actions saved the lives of innocent civilians nearby, his officers and their prisoner. Unfortunately, suspect Duprey, a known member of the Trinitarios street gang who was not wearing a helmet, was killed. Attorney General Leticia James chose to prosecute the Sergeant for Manslaughter, and after a bench trial in February 2026, Sgt. Duran was found guilty of Second-degree Manslaughter.

On April 9th, 2026, Judge Guy Mitchell sentenced the former Sergeant to three to nine years in prison, and he was immediately taken into custody after sentencing in what the National Police Defense Foundation believes is a blatant miscarriage of justice. We believe that Sgt.

Duran never intended for the suspect to be injured or killed. The sole predicate for his actions that day was to protect his officers, other suspects and bystanders from Duprey, who recklessly fled at a high rate of speed along a pedestrian walkway created a clear and present danger of death or serious bodily injuries to others, thereby justifying the Sergeant’s actions.

At the direction of Executive Director Joseph Occhipinti and the Executive Board, the National Police Defense Foundation has created the Sgt. Erik Duran Legal Defense Fund. We encourage all our members to donate whatever they can so that bail can be arranged for the former Sergeant pending appeal.

Thanks for keeping the memory of Murdered Ptl. Phillip Cardillo alive.

Just a reminder of 1990's and later after the Murder of Patrolman Cardillo.

We tried for decades to make sure Phil received the recognition he deserved.

Patrolman Phillip Cardillo made the ultimate sacrifice while serving with NYPD 28th precinct Harem.

Shot at point blank range in the Black Muslim mosque # 7 April 14, 1972 End of Watch April 20, 1972

54 years after his murder, the men that matter still remember.

In the Early 1990's I was already retired and in Florida. I had a chance meeting with a young man in a Deli in Palm Coast that saw my NYC detective shield. We talked NYPD, we went back and forth for a few minutes, he told me his Dad worked in the 28 precinct and I tell him I also worked in the 28. He then tells me his father was officer Phil Cardillo and asked if I knew him. I told him I worked with his father and I was there the day he was murdered. We've been friends ever since.

\*Phil's sacrifice will never be forgotten, 4 books have been written about this incident.

\*Numerous people, Timmy Motto and many others have been instrumental in keeping the Cardillo name in the spotlight.

\*Blue Knights Chapter X in New York have an annual motorcycle ride in honor of Ptl. Cardillo. My wife and I are privileged to ride with over 400 motorcycles to Calvary Cemetery, travel past the Mosque and to the 28 precinct yearly.

\*In 2010 Phil's family and police organizations collected over 3000 signatures on petitions and tried for 4 years to get a street renamed in his honor.

\*Community board 10 told us we needed to get permission from the black Muslim Mosque # 7, that was never to happen.

\*In June 2014 I received a phone call from Det. Randy Jurgensen regarding the naming a library in the new police academy for Benjamin Ward.

\*June 17, 2014 It angered me so that I wrote a letter to a NY Post reporter Philip Messing and told him I was outraged that Benjamin Ward was to have a library in his name in the new police academy, but Patrolman Cardillo still has no public recognition for his death and service to city.

\*June 23, 2014 Mary Murphy New York television station Pix 11 read my letter that was in the NY Post and contacted me. I told her about the events and murder of Patrolman Cardillo. She is interested in doing a story and gets authorization to fly to Florida.

\*July 7, 2014 Mary Murphy flies down with her cameraman John Frasse and interviews Ptl Cardillo's son Todd and myself. Our story was aired on N Y Pix 11 television station.

\*July 15, 2014 she later did an on air interview with both NYPD Police Commissioner Bill Bratton and Mayor Bill DeBlasio about the Cardillo case. They said the PD would look for a way to give a public honor to the slain officer.

\*November 10, 2014 Community board #7 has committed to rename 28th Ave. which is next to the new police academy "Patrolman Phillip Cardillo Way". Remember Patrolman Cardillo was murdered in the 28th precinct.

Updated to timeline:

July 14, 2015 a brand new 70 foot Harbor Launch Patrol Boat # 701 was named in Phil's honor "Patrolman Phillip Cardillo" I was honored to be dock side with Phil's son Todd for the champagne christening. NYPD Police Commissioner Bill Bratton attended and spoke at the dedication.

October 19, 2015 Street renamed in front of new police academy "Patrolman Phillip Cardillo Way" 43 years after Phil was murdered, what a shame.

April 20, 2017 Transit Bureau named a K9 "Cardillo" Phil was shot in the Harlem Mosque April 14, 1972 and on April 20, 1972 6 days later Phil died from his gunshot wound.

46 years to the date Phil's sacrifice is still remembered.

June 12, 2018 K9 Cardillo has his formal graduation at the new Police Academy 130-30 28th Ave. 28th Ave is now "Ptl. Phillip Cardillo Way".

Phil worked and paid the ultimate sacrifice in the 28 precinct so it's fitting that the street named for him was on 28th Ave. I've met P.O. Christopher McGuire and his family on several occasions I felt that K9 Cardillo could not be in better hands. Ptl. Cardillo was only 32 years old when he was taken from us. He was a son, a husband, and a father of three small children. Phil missed out on his son's marriage, the birth of his two grandchildren, and a lifetime of special events.

It's been a long Journey, finally recognition for Phil's ultimate sacrifice.

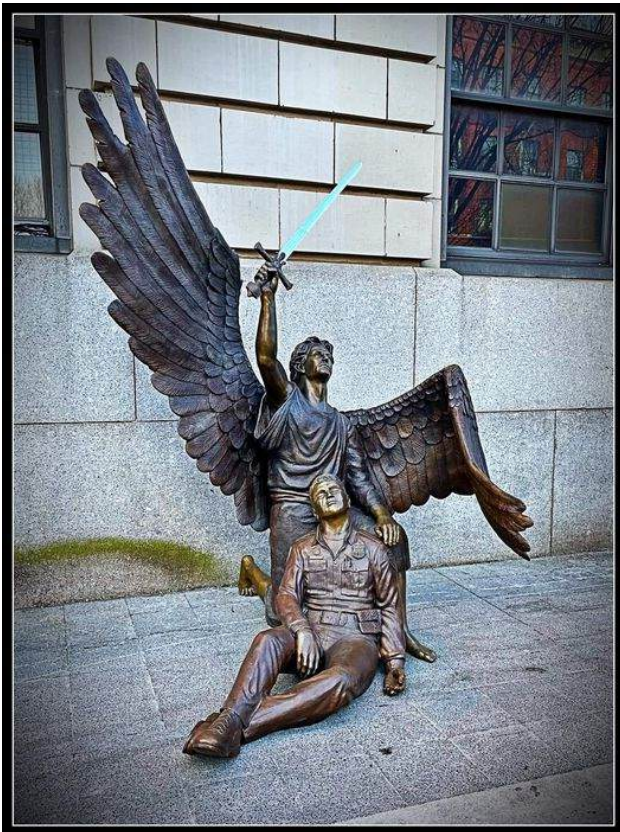

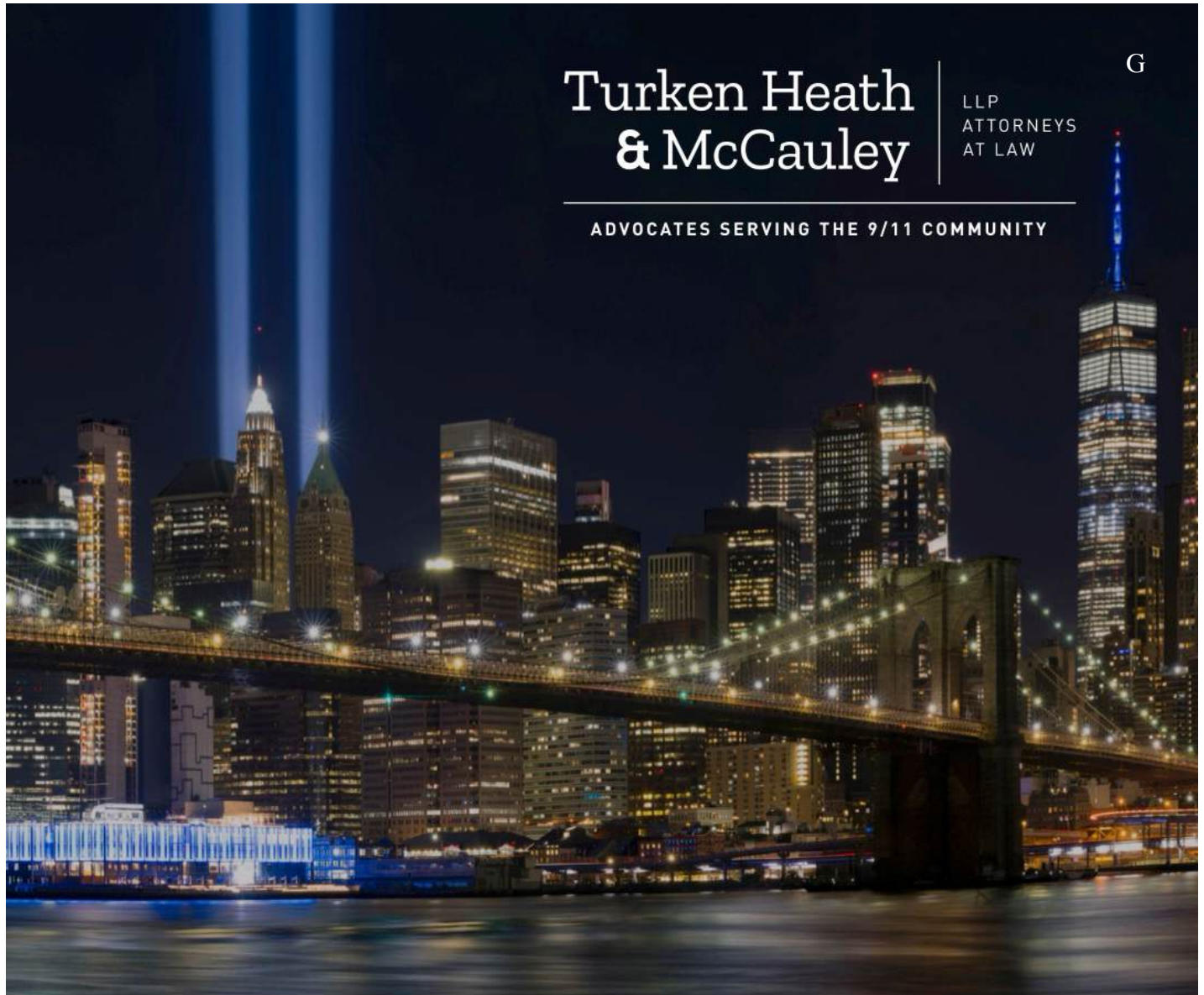
