NYPD Deploy Drones to Help Combat Subway Surfing Teens

"How many times have you interviewed moms and dads who say, my kid would never do something like that. Guess what? The video doesn't lie," said an NYPD official about using drones to stop subway surfing.



NYPD officers have a new tool when it comes to combating subway surfing: drones.

Police have been deploying the flying devices from rooftops to prevent teens from dangerously riding on top of moving subway trains, [WABC-TV reports](#). Video footage from the drone is sent to NYPD headquarters and the Transit Rail Control Center, and officers on the ground are dispatched if anyone is spotted on a train.

The use of drones is part of the city's efforts to keep teens from hopping on top of subway trains. So far this year, at least five people have been killed subway surfing, a total that matches all subway surfing deaths from 2018 to 2022.

Although steps are being taken to deter subway surfing, police aren't using it to arrest teens. If a teen is caught surfing, a report is written up, and the offender's parents and school are informed about what happened.

Bronx triple stabbing: 19-year-old victim's son charged in killings of 5-year-old, couple

THE BRONX - A 19-year-old man, identified as the son of a victim killed in **Sunday's triple fatal stabbing in the Bronx**, has been charged with their murders, the NYPD said.

According to police, Jayden Rivera was arrested Wednesday evening, three days after a 5-year-old boy, his 33-year-old mother and his 38-year-old father were found stabbed to death inside a Mott Haven apartment.

According to police, the man's body was found by neighbors earlier that morning.

"I opened my door to go to work and the body was there," one tenant told FOX 5 NY's Michelle Ross.

Officials made another gruesome discovery when they went inside the apartment and found the 5-year-old boy, identified as Kayden Rivera, and the 33-year-old mother, identified as Hanoi Peralta, dead with stab wounds to the body.

"I know I heard that, and then I heard a woman screaming."

A neighbor who also lived on the first floor said he heard a commotion the night before.

"There was a scuffle or something going on in the hallway," the neighbor, Fernando Cruz, said. "I know I heard that, and then I heard a woman screaming."

Jonathan Rivera was a maintenance worker at a nearby daycare center. His employer described him as a dedicated worker and loving father.

The Post also said the couple, along with their 5-year-old son, were on a date night hours before they were killed.

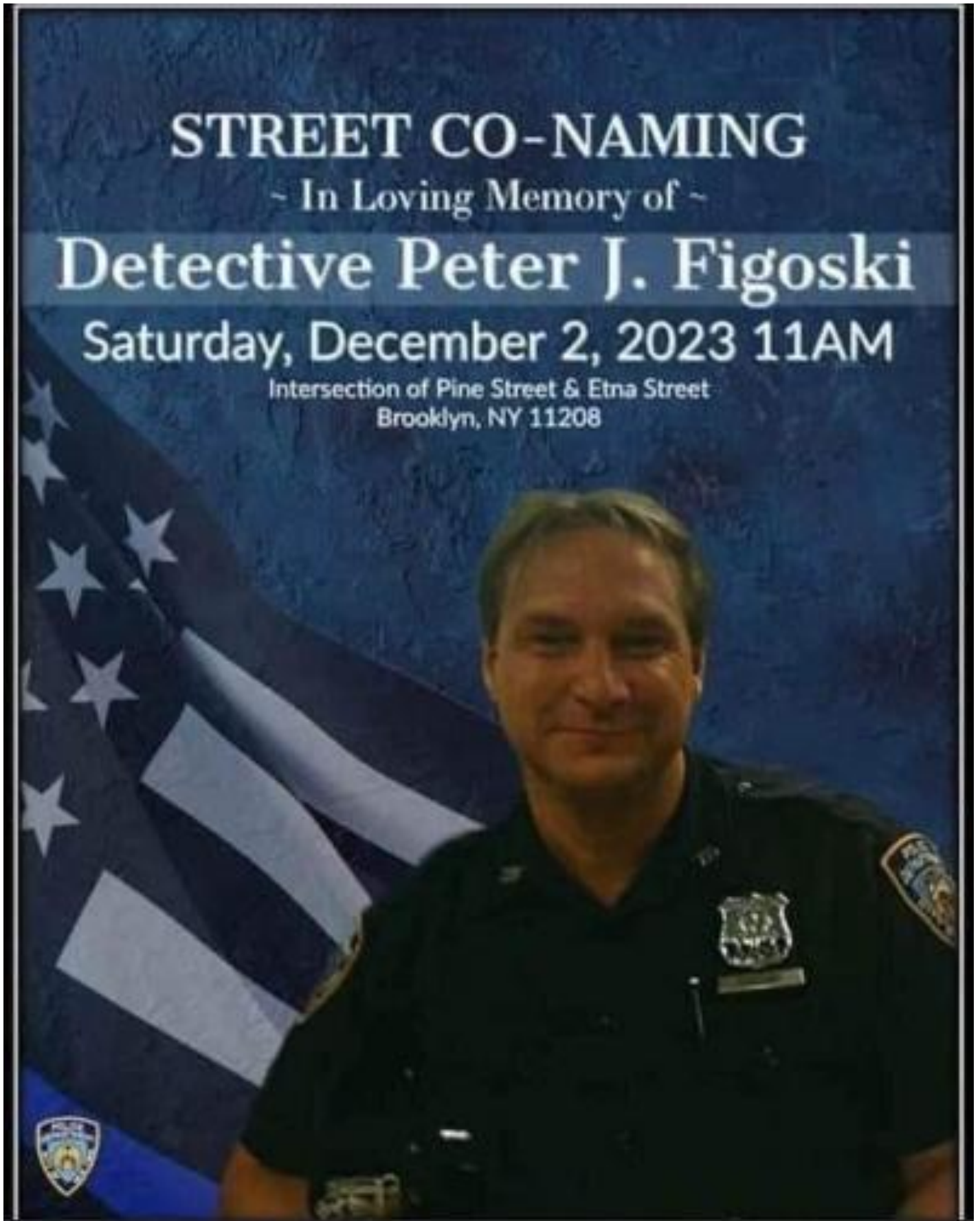
